Gold Card Application – Use of Council Leisure Facilities by Elite Athletes

Individuals who are training for a specific event and/or competition can apply for concessionary use of leisure facilities within the Ards and North Down Borough. The facilities include those at Ards, Comber, Portaferry, Londonderry Park, Bangor Aurora Aquatic and Leisure Complex, Bangor Sportsplex and Queen's Leisure Complex, Holywood. Individuals will be able to avail of swimming pool, gym, sports hall and pitches. Usage of facilities will be subject to availability at the time. No advanced booking will be authorised.

All applicants must:

- be a resident in the Ards and North Down Borough Council area.
- take part in a sport recognised by Sport Northern Ireland through the UK Sports Council's recognition policy and be affiliated to a recognised Governing Body.
- be of amateur status.
- be a member of a sports club in Northern Ireland
- be a member of a recognised elite squad* or be ranked within the top 10 in Northern Ireland. (Elite squad/panel e.g. Ulster, Northern Ireland, Ireland, Great Britain, European and above). This will cover Junior and Senior athletes and be inclusive of those with a disability.
- not be in receipt of lottery or any other grant that would cover the facility element of training costs
- provide selection letter from the relevant SNI recognised Governing Body on official GB headed paper or official GB email statement.
- Be in training for specific named events** and/or competitions. (Must provide evidence of selection/qualification for event)

*Elite Squad/panel e.g. Ulster, Northern Ireland, Ireland, Great Britain, European and above. **Events would include – Interprovincial Championships, Commonwealth Games, European Championships, World Championships, Olympic Games. (It does not include events below Interprovincial Level).

Please note that successful applicants may be requested by the Council to attend the promotion of specific sports events/ schemes during the lifespan of the gold card.

Facilities to be included within the scheme:

- Gym Facilities
- Health Suites
- Swimming Pools
- Sports Specific facilities e.g. synthetic pitches, squash courts (subject to availability)

The extent of concessionary use to be at the discretion of the Head of Leisure.

Duration of free use:

- The concession is only valid while the athlete remains a member of a recognised squad or holds an individual Northern Ireland ranking of 10 and above.
- The concession will cease on the day after the specified event(s).

Successful applicants will be provided with an appropriate membership card that must be shown on each visit to a Leisure facility.

Applications received without the accompanied supporting evidence stated on the application form **will not be assessed.**

DATA PROTECTION

Ards and North Down Borough Council does not have a discretion regarding whether or not to disclose information in response to a request under the Freedom of Information Act, unless an exemption applies. Decisions in relation to disclosure will be taken by appropriate individuals in Ards and North Down Borough Council having due regard to the exemptions available and the Public Interest. Applicants should be aware that despite the availability of some exemptions, information may still be disclosed if the Public Interest in its disclosure outweighs the Public Interest in maintaining the exemption.
